AGENDA ITEM NO 42.11 TO CONSIDER AND APPROVE THE PROPOSAL FOR APPOINTMENT OF CO-GUIDE FOR PG THESIS.

It is submitted that a committee was constituted by the Hon'ble Vice Chancellor under the chairmanship of Dean, PGIMS, Rohtak to submit the proposal for the appointment of co-guide for PG thesis. The meeting of the committee was held on 28.03.2019 & 10.05.2019 and following guidelines have been proposed with reference to thesis of MD/MS/DM/M.Ch.:-

1. A Co-guide/Co-supervisor must be recognized P.G. Teacher as per guidelines of MCl.

- Regarding co-opting Co-guide/Co-supervisor from the subject like Pharmacy, Nursing, Physiotherapy, Dental, Bio-technology etc., a teacher should be considered eligible P.G. Teacher only when Dean Academic Affairs, University of Health Sciences issues a certificate to that effect.
- 3. In case a research project requires inclusion of Co-guide/Co-supervisor from outside the institution and if such a faculty is recognized by other regulatory bodies, the Chairman P.G. Board of Studies may grant one time permission to such a faculty for such thesis project.
- Co-guide/Co-supervisor should be considered from other departments if he/she is likely to contribute significantly with regard to particular thesis topic.
- 5. Co-guide/Co-supervisor should be incorporated from same department if:
 - a) Research methodology requires significant contribution from Co-supervisor.
 - b) Guide/ Supervisor is superannuating before the last date of submission of thesis.

The Committee unanimously feels that the university may kindly consider forming a committee which should dwell on various aspects including appointment of supervisor in P.G. Thesis, format of thesis plan etc. Copy of the minutes of the meeting dated 10.05.2019 is enclosed. (Annexure-42.11/A)

The matter was placed before the Academic Council in its 17th meeting held on 22.09.2020 vide Agenda Item No.17.15 for consideration, approval and recommendation to Executive Council for approval please.

The Academic Council considered and resolved that:-

- A Co-guide/Co-supervisor be appointed from the same department by rotation where PGs have been enrolled.
- A teacher can be appointed a Co-guide who has completed his/her probation period satisfactorily.
- A teacher who is being considered as a Co-guide should have research capabilities.
 He/she should have one research publication as Case Report, Brief communication, Case series, Original paper, Meta-analysis or systematic review or has at least one research project as PI or Co-PI approved by a funding agency.
- 4. A teacher can be appointed as a Co-guide for not more than two PGs.
- Regarding Co-opting Co-guide/Co-supervisor from other Institutions like PGIDS or outside Institutions, a teacher may be considered only when he/she fulfils the experience as a PG Teacher as per MCI Regulations and is approved by the PG Board of the respective specialties.
- 6. These provisions shall be effective w.e.f. the current academic session (2020-21).

The Academic Council further recommended the proposal to the Executive Council for consideration and approval. Hence, the agenda was placed before the Executive Council for consideration and approval.

Minutes of the 42nd Meeting of the Executive Council of Pt. B. D. Sharma University of Health Sciences, Rohtak held on 21.05.2021.

The Executive Council considered and approved the recommendations of the Academic Council with the following amendments: -

- A Co-guide/Co-supervisor should be appointed from the same department by rotation where PGs have been enrolled and where adequate faculty members are available. It will be applicable in all the courses.
- 2. A teacher can be appointed a Co-guide upon having two years experience after joining the concerned department.
- 3. A teacher who is being considered as a Co-guide should have research capabilities as follows: he/she should have one research publication as Brief communication, Case series, Original paper, Meta-analysis or Systematic review or have at least one research project as PI or Co-PI approved by a funding agency.
- 4. A teacher can be appointed as a Co-guide for not more than two PGs.
- Regarding Co-opting Co-guide/Co-supervisor from other Institutions like PGIDS or outside Institutions, he/she should be a PG Teacher in his/her parent institution/university or a researcher with 3 years experience.
- 6. These provisions shall be enforced with effect from the academic session 2021-22.


